Effective Shared Care Agreement for the treatment of Attention Deficit Hyperactivity disorder (ADHD) in children and adolescents with ATOMOXETINE

RESPONSIBILITIES and ROLES

Specialist responsibilities

- 1 Discuss the benefits and side effects of treatment with the patient and carer as appropriate.
- 2 Check for possible drug interactions with atomoxetine and any other medication the patient might be on.
- 3 Discuss the importance of compliance.
- 4 Ensure patient and carers are given sufficient information about the treatment.
- Perform all baseline tests including mental health and social assessment, physical examination, including: assessment of history of exercise syncope, undue breathlessness and other cardiovascular symptoms, family history of cardiac disease, examination of the cardiovascular system; an ECG if there is past medical or family history of serious cardiac disease. Measure baseline, height, weight, blood pressure and pulse and baseline bloods.
- 6 Initiate and stabilise treatment with atomoxetine. Stabilisation will usually take 6 to 12 weeks.
- 7 Supply medication until care is transferred to GP.
- Ask the GP whether he or she is willing to participate in shared care and explain the intention to share care with patient/carer and obtain consent.
- 9 Review patients every 3 months to monitor their blood pressure, pulse and monitor height and weight every 6 months.
- Inform GP of the dose to be prescribed, any changes in dose, when to stop treatment and when to refer the patient back to specialist.
- 11 Ensure GP has access to blood results for information.
- Monitor for side effects and report adverse events to the MHRA and GP where appropriate.
- 13 Inform GP if patient does not attend specialist appointments and action to be taken.
- Have a mechanism in place to receive rapid referral of a patient from the GP in event of deteriorating clinical condition.
- 15 Ensure that clear backup arrangements exist for GPs to obtain advice and support.

General Practitioner responsibilities

- 1 Reply to the request for shared care as soon as possible.
- 2 Prescribe atomoxetine at the dose recommended once patient is established on treatment.
- 3 Ensure compatibility with other concomitant medication.
- 4 Adjust the dose as advised by the specialist.
- 5 Contact the specialist if you suspect the patient is not complying with their medication.
- 6 Check for possible drug interaction when prescribing new medication and avoid prescribing interacting drugs.
- 7 Stop treatment on the advice of the specialist or immediately if an urgent need to stop treatment arises.
- 8 Refer the patient to the specialist if his/her condition deteriorates.
- 9 Report any suspected adverse events to specialist team and any severe adverse events to MHRA.

Patient's / Carer's role

- 1 Take atomoxetine as recommended by specialist.
- 2 Report to the specialist or GP if patient or carer does not have a clear understanding of the treatment.
- 3 Request repeat prescriptions from the GP at least 5 days before the next supply is needed.
- 4 Attend scheduled appointments with specialist and GP as agreed.
- 5 Share any concerns in relation to treatment with GP or specialist.
- 6 Inform specialist or GP of any other medication being taken, including over-the-counter products
- 7 Inform specialist or GP if you feel you are having problems taking your medication or have stopped taking it.
- 8 Report any adverse effects to the specialist or GP.
