EFFECTIVE SHARED CARE AGREEMENT OF METHOTREXATE FOR THE TREATMENT OF INFLAMMATORY BOWEL DISEASE (UNLICENSED INDICATION)

RESPONSIBILITIES and ROLES

Specialist responsibilities

- 1 Discuss the benefits and side effects of treatment with the patient.
- Check for possible drug interactions with Methotrexate and patients regular medication. Avoid prescribing 2 interacting drugs.
- Assess likelihood of compliance. 3
- Ensure patient is given sufficient information about their treatment (including providing a methotrexate 4
- 5 Perform all baseline tests (including FBC, U&Es and LFTs).
- Initiate and stabilise treatment with Methotrexate. Stabilisation will usually take 4-12 weeks. 6
- 7 Supply medication until care is transferred to GP.
- Ask the GP whether he or she is willing to participate in shared care and explain the intention to share care with patient/carer and obtain consent.
- 9 Monitors appropriately as stated on the monitoring requirement in line with the NPSA alert and records this information in the IBD registry
- Inform GP of the dose to be prescribed, any changes in dose, when to stop treatment and when to refer 10 the patient back to specialist.
- Ensure GP has access to blood results for information. 11
- Monitor for side effects and report adverse events to the MHRA and GP where appropriate. 12
- Inform GP if patient does not attend specialist appointments and action to be taken. 13
- 14 Have a mechanism in place to receive rapid referral of a patient from the GP in event of deteriorating clinical condition.
- Ensure that clear backup arrangements exist for GPs to obtain advice and support.

General Practitioner responsibilities

- Reply to the request for shared care as soon as possible. 1
- 2 Prescribe Methotrexate at the dose recommended once patient is established on treatment.
- 3 Ensure compatibility with other concomitant medication.
- 4 Adjust the dose as advised by the specialist.
- 5 Contact the specialist if you suspect the patient is not complying with their medication.
- Check for possible drug interaction when prescribing new medication and avoid prescribing interacting 6 drugs.
- 7 Stop treatment on the advice of the specialist or immediately if an urgent need to stop treatment arises.
- 8 Refer the patient to the specialist if his/her condition deteriorates.
- 9 Report any suspected adverse events to specialist team and any severe adverse events to MHRA.
- 10 Recommend the patient receives an influenza vaccine yearly and pneumococcal vaccine as required.

Patient's / Carer's role

- 1 Take Methotrexate as recommended by specialist.
- Report to the specialist or GP if he / she does not have a clear understanding of the treatment.
- Request repeat prescriptions from the GP at least 5 days before the next supply is needed. 3
- 4 Attend scheduled appointments with specialist, GP and for monitoring.
- 5 Keep the methotrexate booklet up to date and bring this to appointments and when collecting prescriptions.
- 6 Share any concerns in relation to treatment with GP or specialist.
- 7 Inform specialist or GP of any other medication being taken, including over-the-counter products
- 8 Inform specialist or GP if you feel you are having problems taking your medication or have stopped taking it.
- 9 Report any adverse effects to the specialist or GP.
